## AAB COMPETITOR / ENTRANT RACING LICENCE APPLICATION / RENEWAL / UPGRADE FORM 2026

### **GUIDANCE FOR APPLICANTS**

The Automobile Association of Bangladesh (AAB) is the Fédération Internationale de l'Automobile (FIA) Member Club from Bangladesh and the National Sporting Authority (ASN) for motorsport. Only AAB is authorised to issue FIA Racing Licences for Bangladeshis, whether based in Bangladesh or abroad.

New racing licence applicants must meet the eligibility and experience requirements set out below. The appropriate grade of racing licence must be held in order to participate in motorsport events in Bangladesh and abroad. Studying at AAB's Motorsport Academy is recommended for all applicants and is compulsory for most grades of licence.

Existing racing licence holders must renew their licences by 31 December 2025 in order to use their licences from 1 January 2026. All racing licence applications and renewals must be accompanied by AAB's 2026 Medical Form completed by a medical doctor and 2026 Medical Questionnaire. Racing licences are valid only to the end of the calendar year although applications will be accepted at any time of year.

Motorsport can be dangerous and should only be attempted in an AAB-sanctioned environment. Driving in an illegal manner on public roads constitutes a breach of the conditions of this racing licence, as well as the FIA's International Sporting Code and AAB's National Competition Rules. Any such breach would result in suspension or revocation of the holder's racing licence. Participation in unsanctioned motorsport events within Bangladesh or abroad also constitutes such a breach and may result in suspension or revocation of the holder's racing licence. Promotion or glorification of illegal driving on social media is strictly prohibited.

## **FIA World Accident Database (WADB)**

If the licence-holder who is the subject of this application is involved in an accident during a motor sport competition, the licencing authority (the ASN) may be required to submit personal or medical data relating to the circumstances of the accident to the FIA World Accident Database ("WADB").

Accident data collected for the purpose of processing through the WADB shall be neither submitted nor processed unless the Data Subject has expressly consented to this in the following, or equivalent, terms and that consent has been communicated to the Joint Data Controller.

## **WADB Declaration of Consent**

The World Accident Database ("WADB") is an electronic database managed by the FIA and the ASNs (National Sporting Authorities) as Joint Controllers\* (hereinafter "Joint Controllers"). The aim of the WADB is to gather and analyse the circumstances and immediate consequences of racing accidents and/or incidents to improve safety in motor sport.

By ticking the corresponding box:

I consent to the processing, by the Joint Controllers, of my personal data in relation to my involvement in a motor sport accident or incident and its immediate outcome (to the exception of any health-related data), namely identification data, data regarding the conditions under which an accident or incident occurred (car details, competition, location, time), or videos or photographs of the accident or incident, for the purpose of analysing the data to improve safety in motor sport.

I consent to the processing, by the Joint Controllers, of my personal health-related data (sensitive data) in relation to an accident or incident, namely injuries, biometric data related to or collected from my personal protective equipment, or data regarding my physical condition and medical rescue, for the purpose of analysing the data to improve safety in motor sport.
